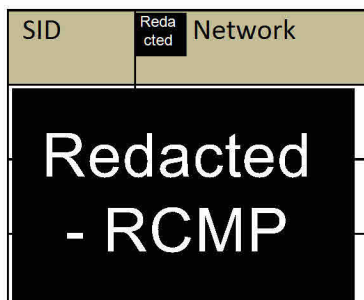

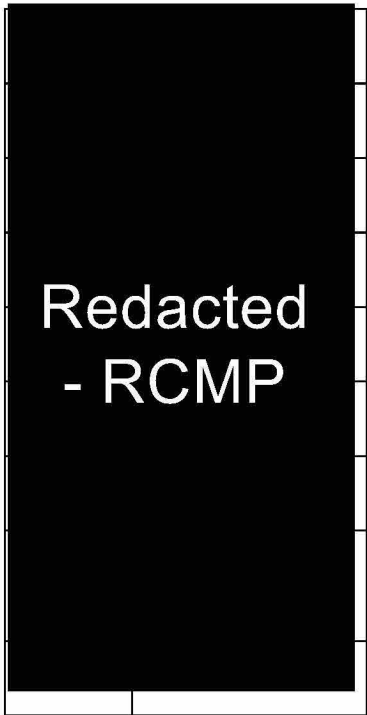
I met with RK today and he has asked if we can get total drop figures for these players for
