- Restructured Investigative and AML departments adding more dedicated resources to AML Intelligence and AML Investigations groups. (including a new AML manager role)
- Funded JIGIT, and established working relationships.
- Provided full day of Industry related training to JIGIT.

- Enhanced 2014 MOU with RCMP to allow proactive sharing of AML related intelligence with JIGIT.
- FinTRAC examination completed.
- Slot machine risk analysis conducted. (internal)
- Delimited amount of Convenience Cheque.
- Enhanced bank draft and non-cash transaction monitoring
- Enabled international wires.
