

3 MR. PINNOCK: Yeah.

MR. HEED: Very few [indiscernible] like you and I 4 5 that really want to do things for the right 6 reasons, and he is certainly one of them. Ross 7 and I are have been in contact back and forth 8 and Sam Cooper was sent a bunch more about me 9 and Sam for some reason didn't really follow up 10 on a lot of it. So Ross was a little 11 frustrated. Ross says, Kash, what am I to do. 12 [Indiscernible] just get this one single thing. 13 I said there is a lot more to it. Lot more to 14 your story. And he says yeah, he wants to get 15 it out. So long story short, I got a connection 16 right to Anton who is the executive producer of 17 W5.

MR. HEED: Anton Koschany. He is a long-time --Koschany, K-o-s-c-h-a-n-y. He has been in the business for years and he was out here for years with the former BCTV, Global. He is well known in the industry.

20	of view because definitely there's conflict
21	there; he is looking at a political part of it;
22	he is looking at the real estate part of it,

12	the whole story is going to be told. They've
13	got they are going to try to talk to
14	[indiscernible]. They know is in a
15	critical conflict because you go to report

17	wasn't a problem, and now he is the DT of BCLC.
18	I suggested they may want to have a discussion
19	with you. They have got all the connections,
20	gamble and [indiscernible], all of that stuff.
21	MR. PINNOCK: Are they going to speak to Campbell?
22	MR. HEED: I don't know. I think they are trying to
23	draw the linkages. They've got the
24	[indiscernible]. They are going to see what the
25	Mounties think of them. They are going after

2	people why they are saying sorry because they
3	are public institution because they've got a
4	connection to this all the way back to PEI. Now
5	what happens is Anton and Kevin had this story

8	what, they have connected it. A massive thing
9	in PEI where people were brought in to
10	[indiscernible]. It's incredible what they
11	learned.
12	MR. PINNOCK: What are they doing in PEI? Is it a
13	[indiscernible] smuggling thing?
14	MR. HEED: Yeah, yeah. It was this one address which
15	is [indiscernible] hotel. 500 people are
16	supposed to be living there.
17	MR. PINNOCK: Wow. That must stick out like a sore
18	thumb in that place. I know PEI well.
19	MR. HEED: Anyhow, that is the piece of the puzzle
20	that you managed to put together on all of this.
21	It's incredible what they have done. So I
22	suggested that they have a conversation with you
23	[indiscernible]. I'll reach out to Fred. I
24	talked to Anton this morning. I said I'll reach
25	out to Fred and see if he is interested.

1 MR. PINNOCK: Let me think about that one, Kash. 2 MR. HEED: Okay. 3 MR. PINNOCK: By the way, I should let you know that if I didn't before, Naomi has been completely 4 5 ostracized by the BC Liberals. 6 MR. HEED: Why? 7 MR. PINNOCK: Her association with me. MR. HEED: Yeah, but who did that? Because I know 8 9 Andrew Wilkinson, and I can't see Andrew doing 10 that. 11 MR. PINNOCK: It would have been him or maybe the 12 caucus chair or maybe Rich Coleman, I don't 13 know, but she is disappointed. She thought some 14 of them were friends, and it's been very little 15 in the way of interaction with them. She has 16 been uninvited to things, and it's hurt her. 17 It's hurt her emotionally. MR. HEED: That's interesting. I [indiscernible] 18 leave behind some of that as I can't see 19 20 [indiscernible] I really can't. Unless someone 21 fed him some bullshit. 22 MR. PINNOCK: There's been definitely an internal 23 agreement that nobody is to interact with her. 24 They are angry with me by association with her. 25 MR. HEED: Get over it. Fucking guys. Get the fuck

1	over it. She wants to run again, tell her to
2	run for the Greens. I knew Weaver quite really.
3	He wanted me to run for him last time.
4	MR. PINNOCK: She is quite green as you know, but I
5	think she's finished with any form of
6	MR. HEED: Politics.
7	MR. PINNOCK: Seeking election for anything.
8	MR. HEED: You know what, I said that but after what
9	is going on with these frigging NDP right now
10	I'm almost wanting to I am not but I'm almost
11	wanting to jump ship because the NDP I'm going
12	to you something, the NDP make Christy Clark
13	look like an angel.
14	MR. PINNOCK: Hmm. I had hopes for David Eby.
15	MR. HEED: I had, but talking heads part of the
16	downside of this story is you are going to
17	see first of all [indiscernible] Ross
18	Alderson as the whistleblower.
19	MR. PINNOCK: M'mm-hmm.
20	MR. HEED: Ross's wife had sent a confidential email
21	to him, and Ross Alderson then sent a
22	confidential email he deleted it out to
23	and BCLC.
24	MR. PINNOCK: Hmm.
25	MR. HEED: When he was confronted, he said it was a

1	mistake.
2	MR. PINNOCK: Yeah.
3	MR. HEED: [Indiscernible].
4	MR. PINNOCK: Yeah.
5	MR. HEED: And he never ever went forward on his
6	whistleblower legislation. So this is all a big
7	part of what they want wanted to come out
8	[indiscernible].
9	MR. PINNOCK: Yeah. M'mm-hmm.
10	MR. HEED: Because you know what the whistleblower
11	legislation policy says in BCLC? The
12	whistleblower policy in BCLC is you're to take
13	it to your boss.
14	MR. PINNOCK: Oh, really?
15	MR. HEED: How fucking ridiculous is that?
16	MR. PINNOCK: Yeah, yeah. Look at who've occupied
17	senior positions there.
18	MR. HEED: Yeah. Yeah. Well
19	MR. PINNOCK: Interesting.
20	MR. HEED: You know, I think definitely Naomi and I
21	need to get together for a coffee or lunch.
22	MR. PINNOCK: M'mm-hmm.
23	MR. HEED: Because I'll tell you, she shouldn't give
24	up, although this is and I can't believe it
25	because Andrew Wilkinson did this, and he's not

1 like that. 2 MR. PINNOCK: M'mm-hmm. Yeah. It may have come from 3 forces within caucus other than him. I don't know. But she was a good soldier, as you know, 4 5 for eight years --6 MR. HEED: Yeah. 7 MR. PINNOCK: And still very loyal to the party 8 and --9 MR. HEED: Not like me. 10 MR. PINNOCK: Well, you're a --11 MR. HEED: I'm a --12 MR. PINNOCK: You're, you know, a pretty fearless 13 get-off-the-fence kind of guy, and not everybody 14 is like you. And it's unfortunate. But anyway, 15 she's, I think, just trying to get on a couple of boards and grow vegetables and ride her bike. 16 17 MR. HEED: Yeah, well, that -- let me see. Well, 18 think about it. I think this is the 19 investigative piece we've been wanting and 20 looking for that nobody's been able to put 21 together on this, and I think this will 22 vindicate people --MR. PINNOCK: M'mm-hmm. 23 24 MR. HEED: -- and show -- first of all, again -- I 25 don't know how much you've [indiscernible].

1		There's a few reasons that this happened, but
2		being the big reason is it's the money.
3	MR.	PINNOCK: Oh, yeah.
4	MR.	HEED: It's all about money.
5	MR.	PINNOCK: We've you and I talked about that
6		nine years ago when I went
7	MR.	HEED: Yeah.
8	MR.	PINNOCK: public.
9	MR.	HEED: Yeah.
10	MR.	PINNOCK: Yeah.
11	MR.	HEED: Yeah.
12	MR.	PINNOCK: I wonder is Sam Cooper going to be
13		interviewed?
14	MR.	HEED: Oh, no, no. The so what we've done
15		is and I've kind of stayed away from Sam a
16		little bit too.
17	MR.	PINNOCK: M'mm-hmm.
18	MR.	HEED: And so has Ross when we went to $W5$ on
19		this. And there are a couple of reasons why.
20		And they are just too bad because I have known
21		Sam for so many years, but the entire story
22		needs to be out there because you know the Sam
23		stories [indiscernible] media [indiscernible].
24	MR.	PINNOCK: Yeah.
25	MR.	HEED: There's no outrage. There's some initial

1	comments and there's no assertive movement to
2	fix it. So that is why going to [indiscernible]
3	W5 which is going to give a national perspective
4	on this and a national exposure to it is very
5	important. It was either going to be $W5$ or the
6	New York Times. Maybe the New York Times, there
7	is a reporter there that is interested in doing
8	this. I'm telling you, if they do it you got a
9	big international [indiscernible].
10	MR. PINNOCK: It will reflect very poorly on
11	BC government, that's for sure.
12	MR. HEED: Yeah, but it should. It should.
13	MR. PINNOCK: Yeah, it should. Now, Kash, what is
14	your sense for [indiscernible] Eby and their
15	inclination to have an inquiry?
16	MR. HEED: I tell you I'm against an inquiry and the
17	reason why I'm against an inquiry here is that
18	the inquiry after the recommendations come out
19	have absolutely no power whatsoever to people in
20	those recommendations at the behest of the
21	current. You got to remember the inquiry
22	there's probably definitely going to be a change
23	of government maybe a couple of times on the
24	inquiries. So at the behest of whatever
25	government party is in power on whether they are

1 going to implement any of the recommendations. 2 MR. PINNOCK: Right.

3 MR. HEED: So that is -- what I am in favour of and it's funny because when I was on NW talking 4 5 about this not too long ago I'm in favour of a judicial review, and the reason I am in favour 6 7 of a judicial review -- and through the next day 8 goes out and says we should do a judicial 9 review. Andrew Wilkinson, and he goes out and 10 says judicial review and uses almost the same 11 lines that I said on why we don't want to go 12 with an inquiry. Inquiries take forever. They 13 are at great costs, and there's no hammer at the 14 end. So that is why the judicial review, 15 it's -- you get someone from former judiciary, 16 whether it's retired supreme court judge or 17 something like that come in, and then he or she 18 have resources to do it, and they have power to ensure that the recommendations are put forth. 19 So that is what I am in favour of for all of 20 21 this. 22 MR. PINNOCK: It will more likely be effective on the 23 heels of a judicial review as opposed to an 24 inquiry. 25

MR. HEED: Exactly, but Horgan said no to judicial

1	review. Let me tell you why he said no to it.
2	It's [indiscernible] to judicial review because
3	judicial review would be done in a matter of
4	months and it may impact them, which I know it
5	will impact them based on what they have done or
6	have not done. We are probably going to go to
7	an election in October this year.
8	[Indiscernible] fiasco has caused so many
9	problems for this government. If they lose
10	Nanaimo, they are finished. We need to go
11	before that. But [indiscernible] so don't be
12	surprised if we face an election in
13	October around the same time as the federal
14	because they will try and get people
15	[indiscernible] as much as they should on these
16	[indiscernible]. So what you'll find is if this
17	starts to have the exposure, if it starts to,
18	for example, after this case is run
19	[indiscernible] start to pick up some grumblings
20	from their constituents and [indiscernible] they
21	will call an inquiry. And the reason they'll
22	call an inquiry is because now everyone has to
23	shut up. Okay. Now they have to shut up. Now
24	that gives them [indiscernible] water for what
25	they have done in order they have to get to the

1	next election because it will be a couple
2	of years before the inquiry recommendations come
3	forward.
4	MR. PINNOCK: Yeah.
5	MR. HEED: It's all political.
6	MR. PINNOCK: Of course it is. I had a visit with
7	Darrell Mussatto two nights ago or three nights
8	ago, and you know where his loyalties lie.
9	MR. HEED: Yeah.
10	MR. PINNOCK: And he is very close friends with Craig
11	Keating the president of the NDP, as you know,
12	and he said that Craig tells him that an inquiry
13	is probable.
14	MR. HEED: Only if it's starting to show that the NDP
15	did not do some things, or for example that
16	was in a conflict that they knew
17	about, then they'll call the inquiry because
18	then they silence. They can't say much. All
19	they can say is we've done our due diligence and
20	we've called the inquiry. They know whatever
21	misgivings Eby or him have done will not come
22	out until after the election.
23	MR. PINNOCK: And they pale in comparison to the
24	senior BC liberals and their head-in-the-sand
25	approach to all the money laundering and

23	MR. PINNOCK: But anyway, this is all super
24	interesting. Let me call you on Wednesday.
25	MR. HEED: Perfect. Perfect.

MR. PINNOCK: Okay, brother, have a good rest of the --MR. HEED: All the best to Naomi too. MR. PINNOCK: Same to you, mister. We'll talk to you on the flip side. MR. HEED: Thanks. MR. PINNOCK: Happy New Year. Bye. MR. HEED: Bye. MR. PINNOCK: 12:17. (RECORDING ENDS)
