## A GUIDE ON READING THE ORGANIZATIONAL CHART

Each square in the organizational chart represents a position with the following field:

- Employee Name
- Job Title
- Job Classification
- Job Category

### What does each field mean?

**Employee Name:** Name of Employee

**Job Title:** Official title of job within the organization

**Job Classification:** The level of the job functions relations to the BCFSa compensation framework

**Job Category:** Identifies whether the job is considered to be Management (MGMT) or Non-Management (Non-MGMT)

In the Terms and Conditions of Employment, Management Employee are employees who are employed:

- to exercise the functions, and do exercise the functions, of a manager or superintendent in the direction or control of employees,
- in a confidential planning or advisory position in the development of management policy for the BCFSa, or
- in a confidential capacity in matters relating to labour relations or personnel

#### EXAMPLE:

Employee Name	Jane Doe
Job Title	Records Clerk
Job Classification - Job Category	Level 1 – Non-MGMT

### Please Note:

- Contractors are not included in the organizational chart
- The coloured positions with a dash-line border are employees who are temporarily with the organization, such as:
  - Contract Employee - Formerly called Auxiliary
  - Secondment – Employees from a BC Government Ministry joining BCFSa temporarily

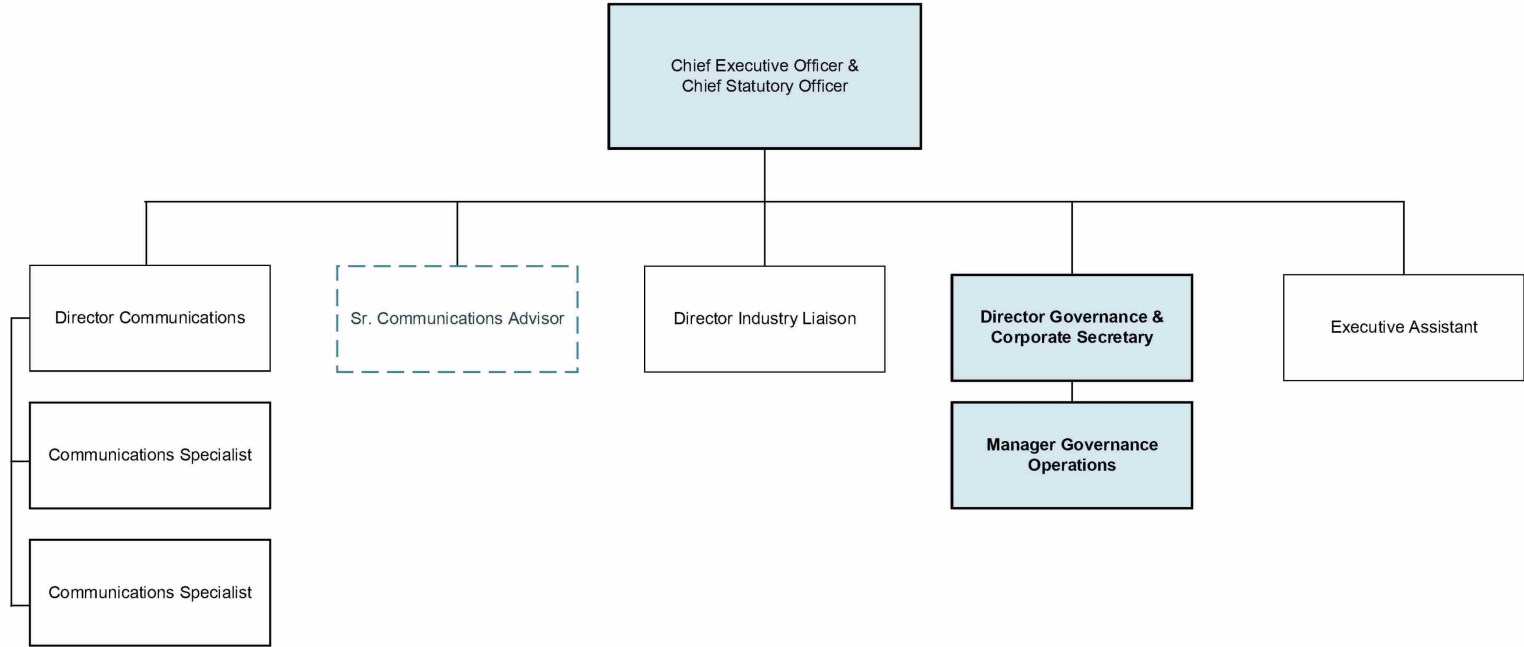

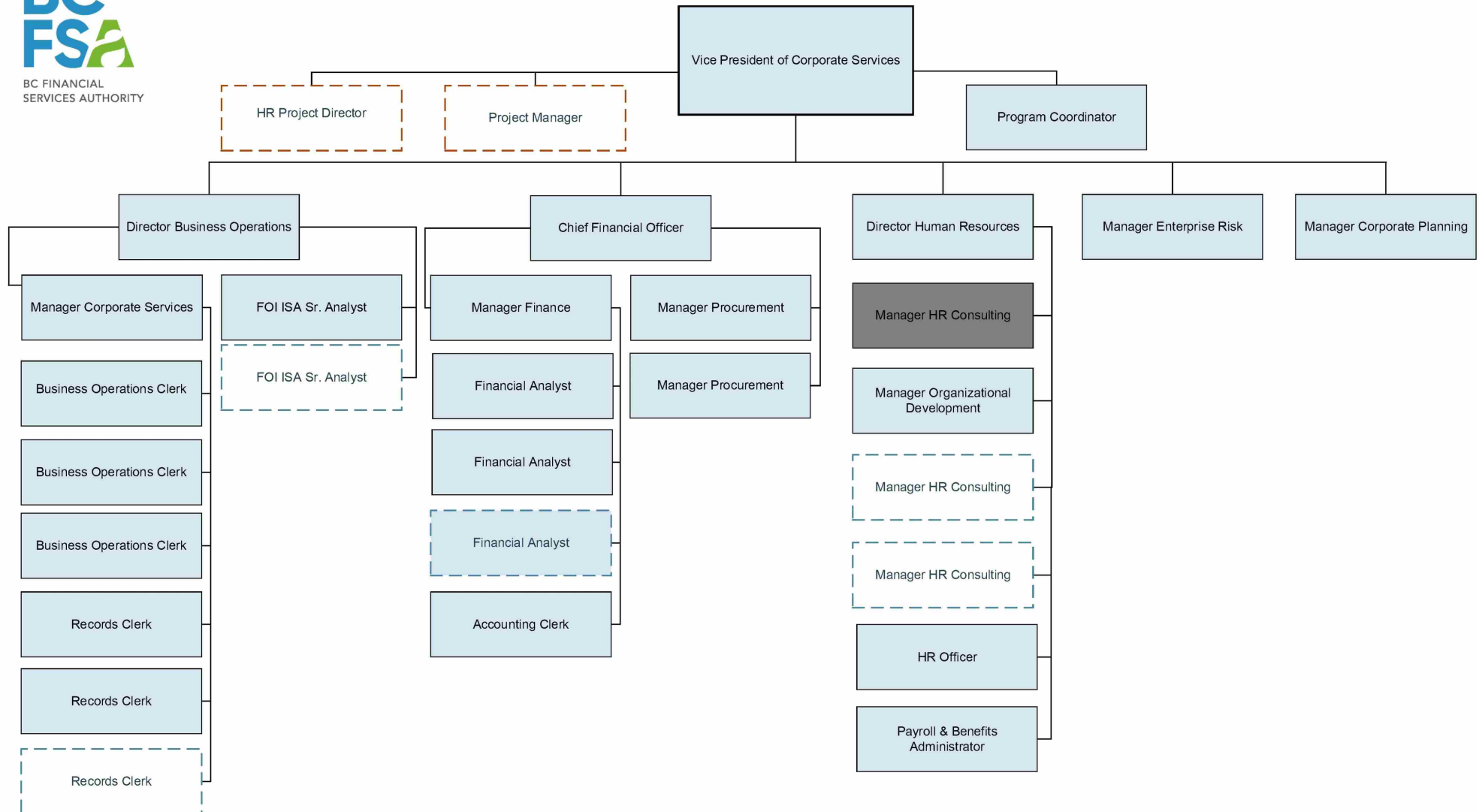

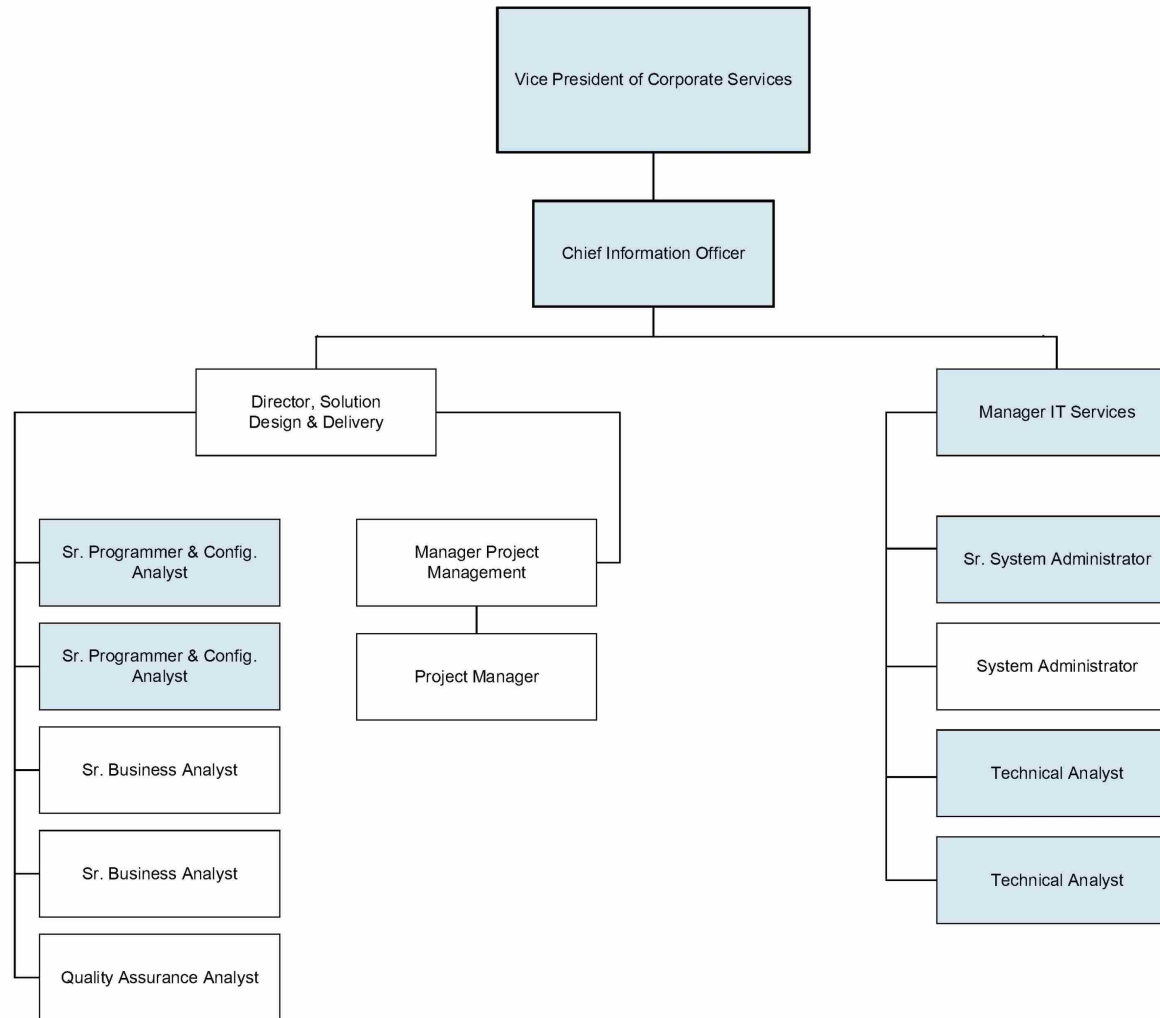

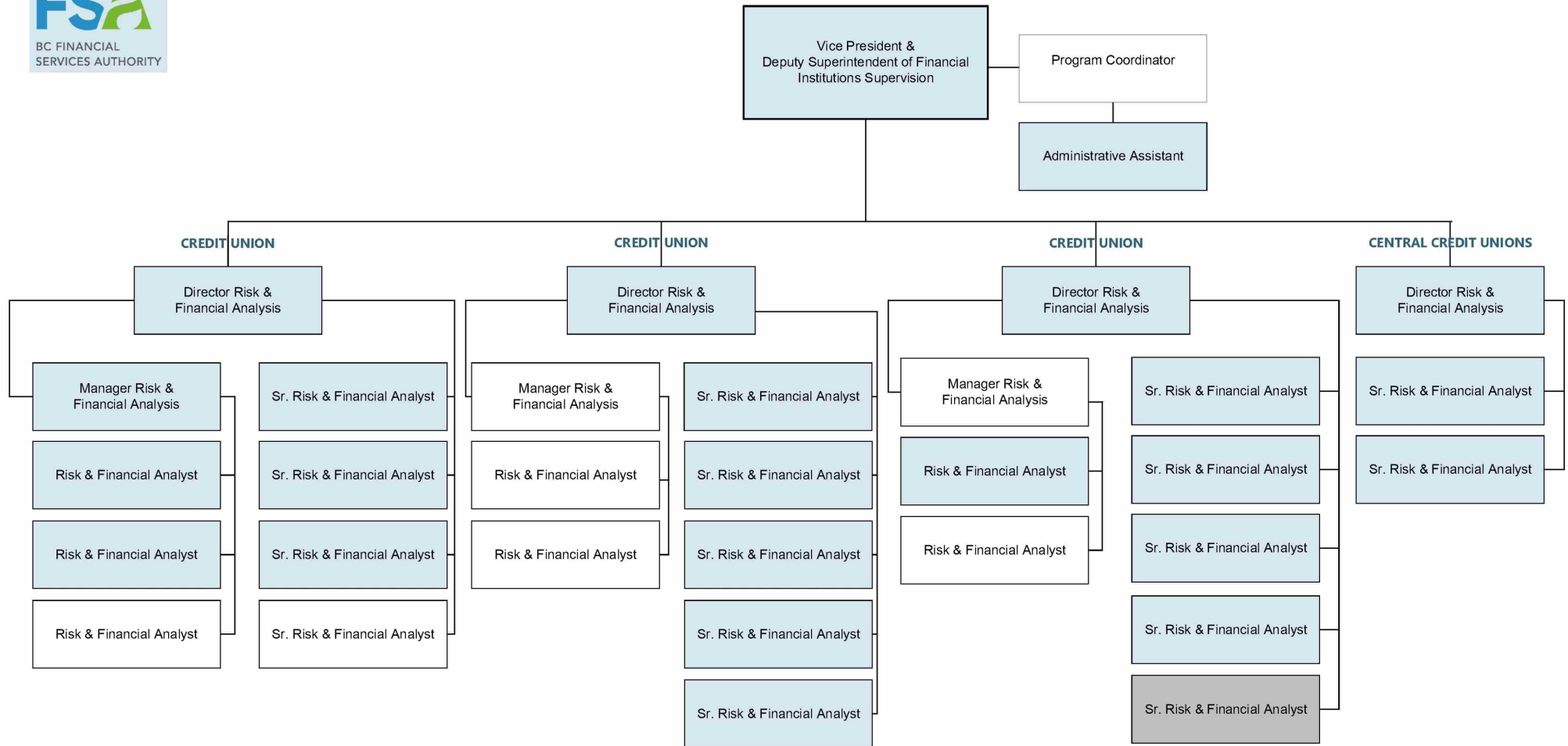

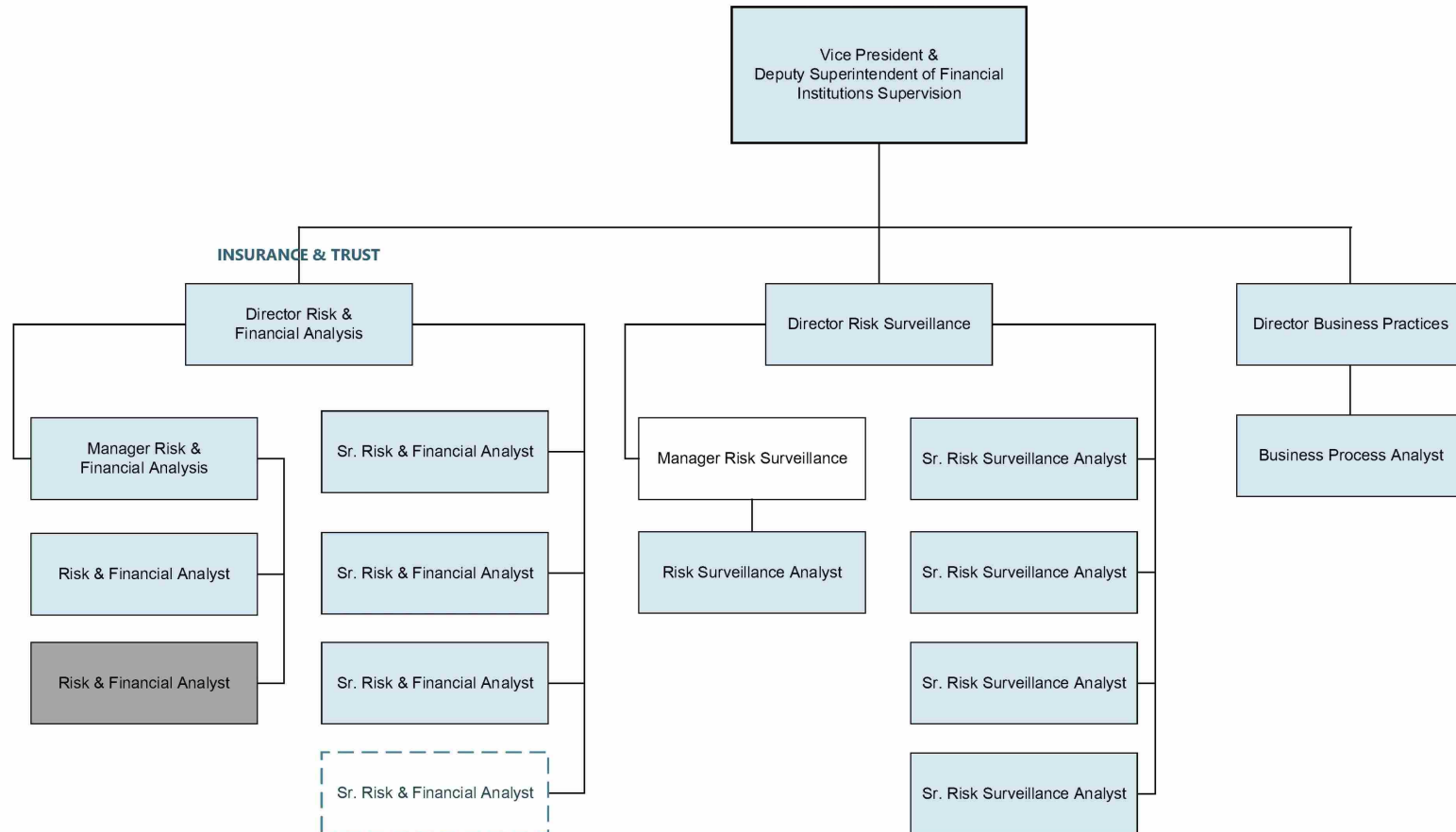

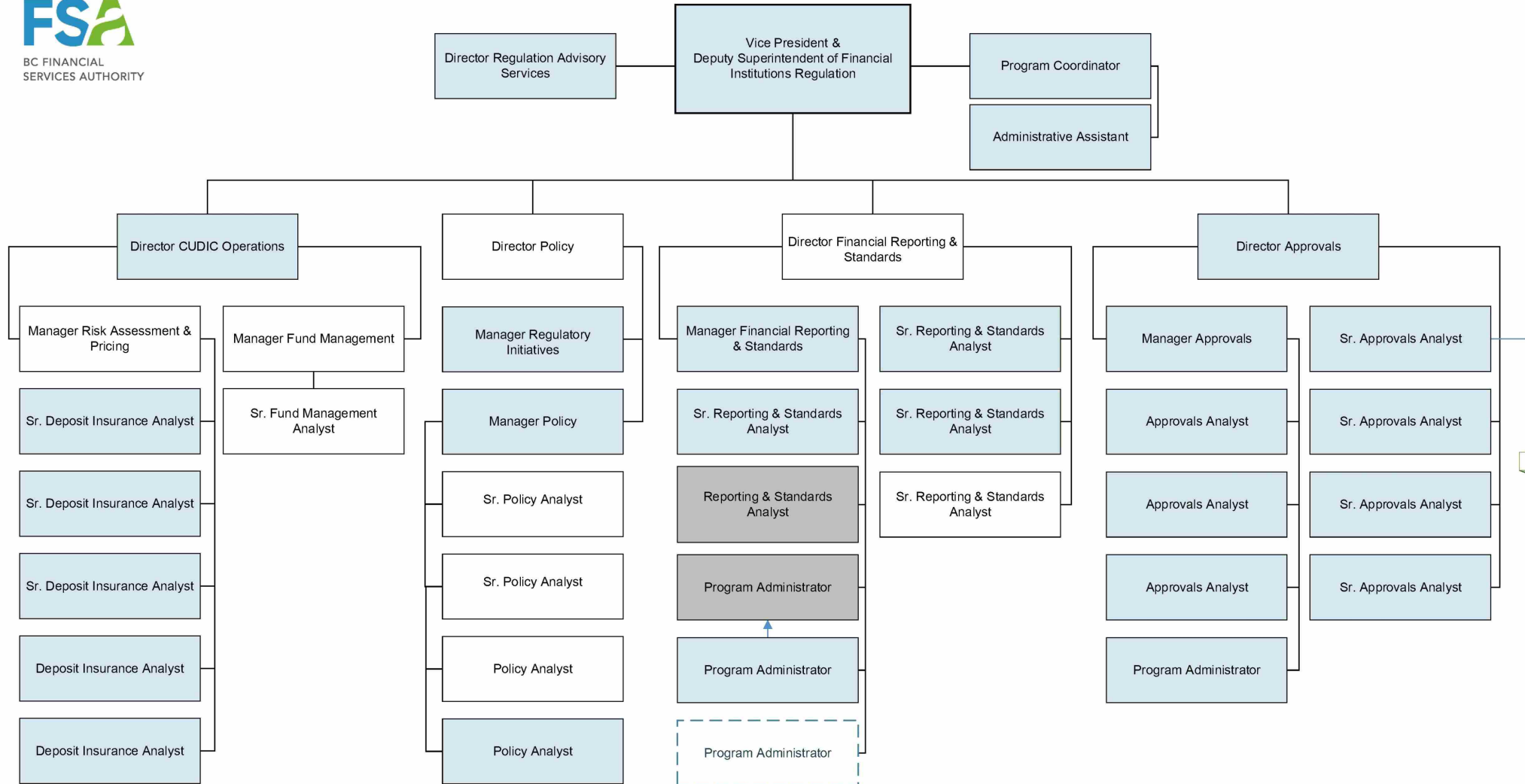

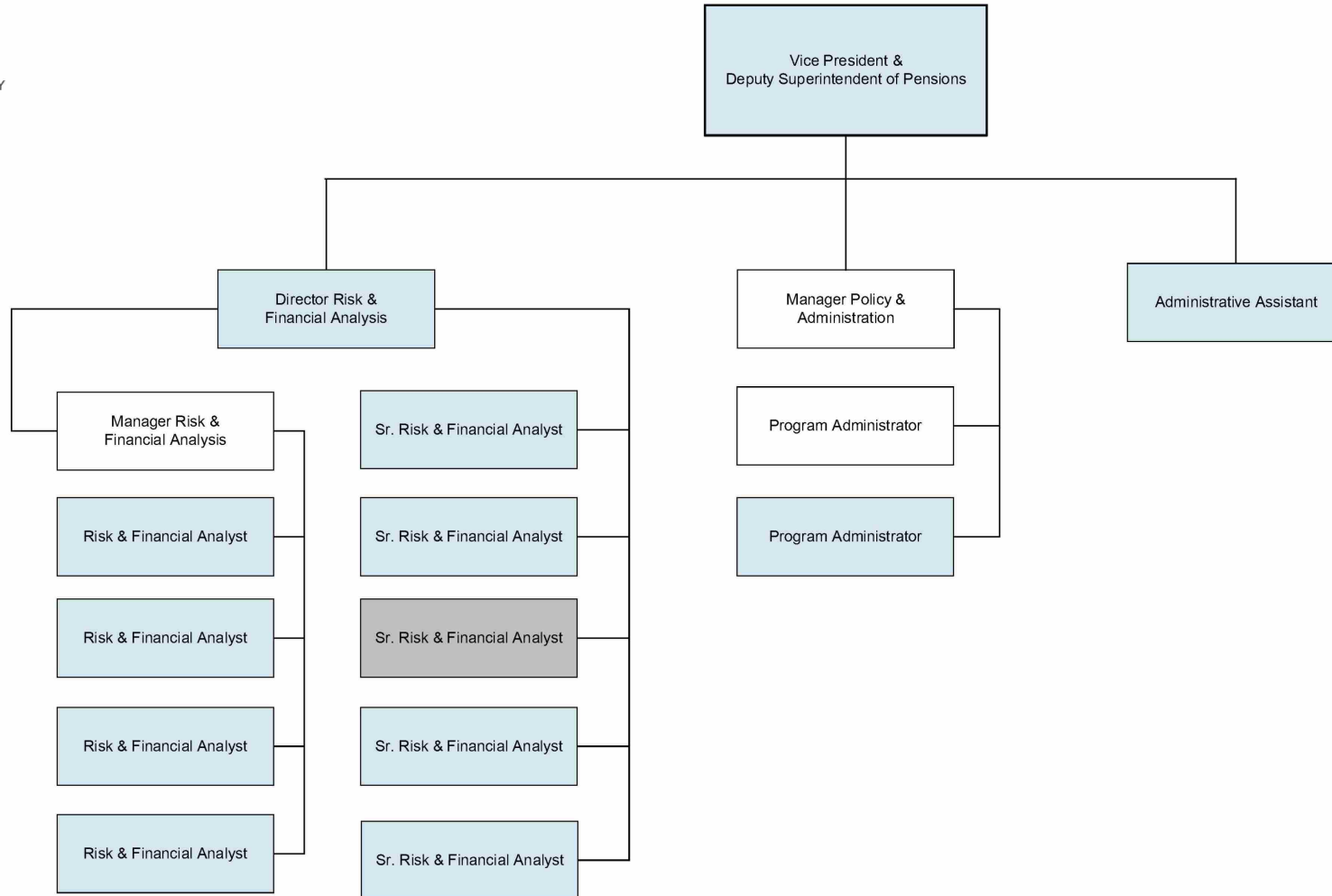

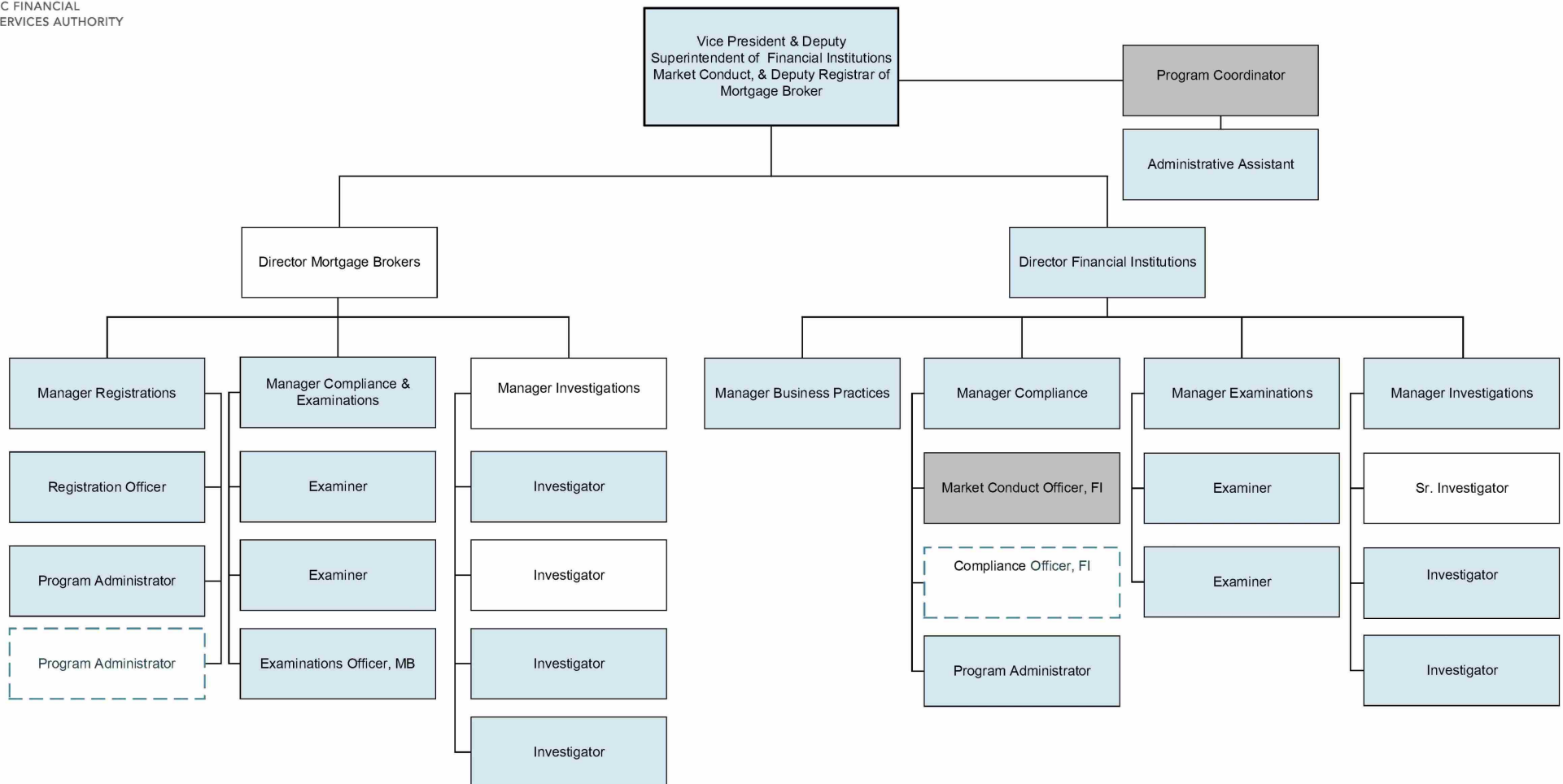
