Female complains to BCLC Consumer Services that Gateway Guest Services Employee Maggie **CHIU** introduced her husband to a "loan shark". As such, as lost over \$1,000,000 at the Villa and the Starlight.

# 2. February 27, 2015 - BCLC IN20150010775

Gateway Executive Director of VIP Bill **LANG** and Gateway Guest Services Employee Maggie **CHIU** are observed meeting with and talking to, "High Risk Patrons" Chang Hu **LIU** (SID#: 24307), [CSID#: 10418], [CSID#: 36465], and BCLC Barred Patron (Loan Sharking) Paul King **JIN** (SID#: 118414) outside of the Starlight Casino. The content of this meeting is unknown.

# 3. March 4, 2015 - BCLC IN20150011894

(SID#: 99395) is observed in the Starlight parking lot, receiving approx. \$50K from two (2) U/K individuals who arrived in a vehicle known to be associated to BCLC Barred Patron (Loan Sharking) Paul King **JIN** (SID#: 118414).

# 4. March 5, 2015 - BCLC IN20150012045

(SID#: 99395) and "High Risk Patron" (SID#: 76259) are observed arriving at Starlight in a grey Mercedes. Proceeds to buy-in and play with approx. \$100K.

Gateway Guest Services Employee Maggie CHIU is observed being in the Starlight Shang Noodle House, at the same time as BCLC Barred Patron (Loan Sharking) Jack QIN (SID#: 73465) and ex-Gateway Guest Services Employees Mandy LI and Claudia YEUNG.

After loses all of his money, enters the Shang Noodle House, the same time the above noted individuals are in said restaurant. Gateway Guest Services Employee Maggie CHIU is then observed leaving the Shang Noodle House, and meeting directly with on the VIP Smoking Patio. At around the same time, exits the restaurant and retrieves approx. \$90K from the grey Mercedes. To note, at some point between the time and first arrived, and the time retrieved the \$90K from the grey Mercedes, BCLC Barred Patron (Loan Sharking) Jack QIN (SID#: 73465) entered the same vehicle, drove it off site for approx. 45 minutes, before returning it.

After retrieved the \$90K from the grey Mercedes, Jack QIN is observed meeting with Gateway Guest Services Employee Linda WANG near the front entrance to the Starlight, and receives from WANG what appears to be a complimentary taxi voucher. Jack QIN then leaves the site in a taxi.
