Leadership of EU law enforcement agency, charged with coordinating effective multinational actions against cyber, terrorist, and organised crime threats in Europe – 1,000 people, €115m budget, operational network spanning 1,200+ law enforcement agencies and 100+ private sector partners in 40 countries – key influencer in government and private sectors in Europe and US on security and geopolitical affairs.

Led major reform of Europol to become the leading intelligence and operational hub for police cooperation in Europe

- Built new information sharing and data analytics platform connecting over 1,200 participating agencies, recording nine-fold increase in information sharing levels over 9 years;
- Developed Europol into a major transatlantic security hub, involving cooperation with over a dozen US federal law enforcement and intelligence agencies;
- Led the reform of police cooperation arrangements in Europe, instituting new policy and structures to align strategy and operations across thousands of law enforcement agencies – now enshrined in the EU's Security Union Strategy;
- Established the European Cybercrime Centre (EC3) at Europol in 2013 and the European Counter Terrorist Centre at Europol in 2016, as the primary European intelligence-sharing and operational centres in these fields;
- Established major new public-private initiative with Institute of International Finance to reform global anti money laundering cooperation between law enforcement and banks.
