





His honours and awards include Queen's Counsel, Officer of the Order of Merit of Police Forces, the Queen Elizabeth II Golden and Diamond Jubilee Medals, the Gold Medal of the International Society for the Reform of Criminal Law, and Queen's Counsel and the RCMP Long Service Medal with silver bar. 

As a US federal prosecutor for over 30 years, **Stefan D. Cassella** was one of the country's leading experts on asset forfeiture and money laundering law. He now serves as an expert witness and consultant to law enforcement agencies and the private sector as the CEO of Asset Forfeiture Law, LLC.
