Thank you for your email of 17 June 2017 requesting information from the New Zealand Police under the Official Information Act 1982. Parts 2 & 3 of your request have been transferred to the Ministry of Health.

- 2. How much of this money was spent on funding for rehabilitation services/centres and ensuring new support measures for drug addicts were readily available across the entire country.
- 3. Please name specific rehabilitation centres and or projects that were built and/or funded by this money.

Value of cash and assets seized under the Misuse of drugs Act/Asset forfeiture during 2011-2016

The annual funds paid into the Proceeds of Crime Fund since the passing of the Criminal Proceeds (Recovery) Act 2009 were \$4.105m in 2012/13, \$6.937m in 2013/14, \$5.866m in 2015/16 and \$14.087m in 2016/17, totalling \$30.995m.

Proceeds of Crime funds spent on support services for drug users during 2011-201 Forty-three percent of this money (\$13.572m) has been spent on rehabilitation and other support measures for drug users.
